As an independent distributor of FRAGANNET SDN BHD, I understand and agree to the followings:

- 1. I hereby apply for distributorship authorisation and I understand and agree that in order to remain a distributor. I am of legal age (18 or above) and I am a Malaysian or a Permanent Resident of Malaysia.

- I hereby declare that I am not an undischarged bankrupt. I will file all returns and reports required by the Inland Revenue

 - I understand that I am an independant distributor and not an employee, agent, partner or joint venture partner of FRAGANNET SDN BHD or my sponsor, and that I am not authorised to act on behalf of or to bind FRAGANNET SDN BHD or any of its affiliate, shareholders, officers, directors, employees or agents, or my sponsor.
- 4. I will not use FRAGANNET SDN BHD's trade name, trademark, or service mark in any advertising including in the Internet without prior written approval of FRAGANNET SDN BHD.
- 5. I will not use or disseminate any literature or sales aids whatsoever other than those obtained from FRAGANNET SDN BHD. I will not alter any product contents or packaging without specific written approval from FRAGANNET SDN BHD. I will not sell any product similar with FRAGANNET SDN BHD.
- 6. I will describe FRAGANNET SDN BHD's product honestly and completely. FRACO is a health product and not a medicine. I will not make any false claim concerning the product. I will further emphasise FRAGANNET SDN BHD's commitment to quality control.
- 7. I understand and agree that if at anytime I breach any of the terms and conditions of this Agreement or engaged in any conduct which may bring dispute upon FRAGANNET SDN BHD or FRAGANNET's product or which violates any government law, acts, regulation or ordinance, or any FRAGANNET SDN BHD's policies or procedures, FRAGANNET SDN BHD may take appropriate action on my distributorship.
